





#### ISO MANAGEMENT SYSTEM APPROACH

# **FSSC 24000**

#### **FEATURES**

- Social Management System (SMS) ISO-aligned;
- Voluntary Certification Scheme, developed in extensive and open consultation with global stakeholders;
- Aim: ensure organizations provide safe and fair working conditions, meet business ethics requirements, and apply due diligence in their supply chain management;
- Recognition to Certified Organizations through a public register;
- Governance and oversight of certification through the Foundation's Integrity Program = TRUST;

#### **SCOPE**

- Organizations in the consumer goods manufacturing and processing sector (food and non-food), including their related service providers.
- Scope refers to the economic sector/activity with related IAF codes (see IAF scope document IAF ID1 on next slide).
  - Exclusions: Processing and manufacturing and the related trade of tobacco and tobacco products, fur and fur products, weapons, explosives and ammunition, and nuclear fuel products.

PAS 24000 chapters 4-10 provides a common framework across the supply chain to manage requirements and communication and continually improve the system.

PAS 24000 Annex A PAS 24000 Annex A defines minimum requirements to ensure a base level of social performance.

FSSC 24000 Requirements FSSC 24000 specific requirements ensure consistency and integrity, and provide governance and management of the scheme.


# BOARD OF STAKEHOLDER DECISION LIST

- Contains mandatory decisions with implementation timelines applicable to FSSC 24000 Scheme.
- The decisions overrule or clarify existing Scheme rules with defined transition periods.
- The decision list is dynamic and can be adjusted by the BoS when necessary.
- The BoS is responsible for approval of the content and functioning of the FSSC 24000 scheme.
- Provide binding decisions and voluntary recommendations for the associated Certification Bodies and Accreditation Bodies.
- The latest BoS decision list is available on the FSSC website under Scheme Documents.



#### PAS 24000

- Requirements for a social management system (SMS):
  - Framework of policies, processes, and procedures used by an organization to ensure that it can fulfill all tasks required to achieve its social objectives so that its workers are:
    - ✓ treated fairly, and
    - ✓ provided with a safe working environment.
- Minimum requirements for a base level of social performance:
  - Labor relationships
  - Human rights
  - Health and safety
  - Work and business ethics
- BSI commitment to make PAS 24000 a standard of the ISO family in the future.
