ABOUT THE COURSE

FRMC24: Fundamentals in Regulatory Management of Chemicals is a fully digital Certificate Course designed for those who would like to learn more about product compliance and its related chemical regulatory requirements.

The course is developed and taught by Regulatory Representatives and Managers Association (RRMA), Global Product Compliance (GPC) and Indian Institute of Management Mumbai (IIM Mumbai). The lecturers of the course are experts in the field of compliance with rich industrial experiences, as well as academics from the field of sustainability and compliance.

COURSE FOCUS

This course is an introduction to product compliance and its related chemical regulatory requirements and developments. It introduces key terms and concepts and explains the general approach from a global perspective. Topics addressed include:

- · What are product related technical regulations?
- What are the international conventions on use of chemicals?
- How to regulate chemicals via technical regulations?
- Where can information about hazards and risks of a chemical be found?
- How are chemicals managed on a national, regional and global level?
- What are the linkages between product sustainability and ESG and climate strategies?

MODULES

The course is structured into 7 Modules and 1 final assignment. In order to partake in the course, all Modules have to be taken, they cannot be attended separately:

1: Sustainable Development Frameworks	2: Introduction to Product Compliance
3: Governance of Chemical Compliance	4: GHS, Chemical Classification and Labelling
5: National Chemical Regulations	6: Compliance Management
7: Sustainable Supply Chain Management	8: Final Assignment







TARGET AUDIENCE

The course is open both for working Executives who are working in a relevant field such as product or chemical compliance; as well as (post-graduate) University students who are currently enrolled in Higher Education studies.

All course content, including lectures, assignments and exams, is fully accessible online, and the course is designed to be compatible with working hours and workload.



SCHEDULE

The course starts in early July, 2024 and runs for 4 months.

Lectures for the Modules are held every two weeks during this period. All forms of assignments are meant to be completed in the time during the Modules. The final project will be worked on independently after this time.
